- What is the CASA organization dedicated to improving? CASA is dedicated to improving governmental accountability and efficiency in the State of California. By collaborating and providing training opportunities, CASA aims to strengthen the audit profession and contribute to the responsible and effective use of public resources in California.
- 2. On average, how many training courses does CASA provide each calendar year? **11 (CASA normally does not hold training in December).**
