

# CASA Treasurer Laura Langston

Laura started with the state in 2009 as a 911 Dispatcher for the California Highway Patrol. She worked nights and finished up her accounting degree during the day and switched to auditing in 2012 upon graduation. She started working at the Department of Health Care Services, where Shanah McKnight was the training coordinator. One of the trainers that Shanah hired was Chuck Hester to provide an inhouse regulatory review training. Laura was always looking for qualities in other people and seeing Chuck present made her wonder how she can become distinguished enough to be hired to present auditing requirements in front of hundreds of people. During his presentation, Chuck talked about the value of being on the board of an audit organization and mentioned that the California Board of Accountancy was waiving some of their CPA candidate fees. Immediately after his training Laura started her paperwork to become a CPA. Then, a few weeks later, she went to her first CASA breakfast meeting where it was announced that they were looking for a Secretary, so she signed up to join the board. That was in 2016. Laura has been the Treasurer since then and is the longest running member on the board.
